The privacy of your personal information is important to BiopTis. We therefore do everything we can to respect your privacy in relation to the use you make of this site. Please find hereunder the terms and conditions related to the process of your personal data; how we use your information; how we protect it and our policy related to "cookies" and "action tags".

1 - Collect of personal data

You may visit our site, obtain information on our services or products and make yourself acquainted with our most recent news with no obligation to furnish any personal information.

However, in certain circumstances BiopTis may seek additional personal information when you register on our Website or when you place your order.

Personal data we may ask you are:

2 - Act of 8 December 1992 on the protection of privacy in relation to the processing of personal data

Right of access, objections and rectifications.

10 - Period for which your personal data is kept

11 - "Cookies "and "actions tags"

BiopTis also collect non-personally identifiable information passively using "cookies" and "action tags".

"Cookies" are small text files that are placed on your computer in order to identify your web browser and the activities of your computer on our website and other websites. We may use Cookies to allow us to statistically monitor how you are using our website to help us improve our website, or to determine the popularity of certain content. Although most browsers are initially set to accept cookies, you may reset your browser to notify you when you receive a cookie or to reject cookies generally.
